It is a privately-owned prison that contracts with the state of Montana to house about 750 male felons...The chaplain is a dedicated follower of Jesus and has opened this door for us...Our February visit gave us the opportunity to speak to 17 inmates...we praise the Lord for our church men who are quite excited to be a part of this ministry...As we ended (the last session), I asked the inmates if they had any prayer requests...One said, 'I pray that you will come back.'
